


30-SECOND SPEECH BY BRYAN DYSON, (FORMER CEO OF COCA-COLA)

4 WEEK JUMP START: INSTAGRAM WEEK 1

Over the next four weeks, this section will feature simple instructions to create a small business Instagram profile. Keep checking back to make sure you're making the most of this powerful platform!

First and foremost, the Instagram BIO section is one of the most important sections for businesses to optimize. The first thing that regional businesses should do is mention their LOCATION or territory, preferably as a hashtag (i.e. #OrangeCounty).

Second, PROVIDE A SOLUTION in the description. Make it specific and succinct, and try to use just one sentence. It's ok to have a niche—it helps with targeting your demographic.

If you have bragging rights, such as how many years the business has existed, notable clients, or credentials, work these into your description, too.

Use a business logo for the profile image, or if you're a 1-person brand, use a headshot to give the profile a "voice".

Lastly, choose an Instagram handle that is easy to read, such as <u>@executivesassoc</u>.


An Advance Health Care Directive does two things: it identifies the person or persons you trust to make health care decisions for you if you can't make them and it includes your direction about specific issues such as life support, burial, and organ donations.

California rules say your spouse can make decisions for you if you cannot. If you do not have a spouse, then your children can make decisions together. If they do not agree, then who suffers? You do, because you wait in a facility without treatment until they reach an agreement.

You can use an advance health care directive to avoid these stalemates by identifying one child who has ultimate decision-making authority. Sometimes it's appropriate to name someone other than a spouse or child for this difficult task.


