Five to fifteen complaints are being filed in Orange County each day against firms with websites that are not ADA compliant. There are accessibility guidelines for disabled individuals. Websites need to be compatible with screen readers. The website developer needs to add hidden tags to direct the screen readers. Also images must have tags and videos need text transcripts.

Lydia said that hotels and fast food franchises with a physical location in California are the most at risk. There are accessibility checker applications and Jub Jub Interactive is available to bring your website into compliance.
